## Entry Form

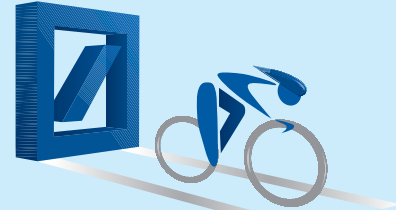
Race Registration at the Expo on

All participants must collect their start packs on 6 & 7 October between 10am and 4pm and on 8 October from 10am until 12 noon. The timing system has changed this year and in place of the transponder that is usually supplied and worn on the ankle, a stick on barcode will be supplied in each start pack. This barcode must be placed on the left hand side of the helmet. The race number is to be pinned on the back of the cyclist's shirt.

## Rules

1. Safety approved helmets are compulsory.
2. Seconding of cyclist of any form from motorised vehicles is strictly prohibited.
3. Cyclists who complete the 100km Ride within 6 hours and the 50km Ride within 3 hours will receive a medal.
4. A participant must be at least 13 years of age on the date of the race.
5. You may not deviate from the race route.
6. The use of cell phones on the route is strictly prohibited by any participant.
7. The race shall take place despite weather conditions, unless the organisers deem it necessary to cancel or postpone the tour.
8. Participants starting the race in the incorrect group will be disqualified.

## Corporate Challenge Rules

1. Teams must comprise of 5 cyclists.
2. One licenced cyclist may be part of a Corporate team.
3. The time of the third fastest cyclist will be the time of the whole group
